Benefits Briefing Webinar: DOL Proposed Regulations on Electronic Disclosure Friday, November 8, 2:00 p.m. ET

The American Benefits Council will hold a **Benefits Briefing webinar** on **Friday, November 8, at 2 p.m. Eastern Time**, to review the recently proposed regulations that would expand electronic disclosure of retirement plan documents (as described in the [October 22 Benefits Byte](#).)

In this webinar, moderator **Jan Jacobson**, *senior counsel, retirement policy*, will be joined by [Chris Gaston](#), *senior policy director*, and [Michael Hadley](#), *partner, both with Davis and Harman LLP*, who will provide an overview of the proposal and what it means for retirement plan sponsors.

We will also be joined by [Seth Perretta](#), *principal, Groom Law Group, Chartered*, who will discuss the implications of the proposal for health and welfare plans. The proposed rule does not specifically address health plans, though it reserves a section on health and welfare plans for further study.
