The American Benefits Council will continue its **P4P ... Preparing for PPACA** series on **Friday, June 28, at 2:00 p.m. Eastern Time**, to discuss [DOL Technical Release 2013-02](#), temporary guidance implementing the Patient Protection and Affordable Care Act (PPACA) required notice to employees regarding coverage options through the Marketplaces (formerly referred to as Exchanges). The Technical Release was issued along with a model notice and revised COBRA and election notices (See the [May 8 Benefits Byte](#) for links and more details.)

PPACA amended the Fair Labor Standards Act to require that employers provide each employee with a written notice providing the employee with information about the exchange and how to request assistance, describing the availability of a premium tax credit (if applicable) and outlining the implications for the employee if they choose to purchase a qualified health plan through an exchange.

According to Technical Release 2013-02, employers must provide the notice to current employees by October 1, 2013. Employers are required to provide the notice to each new employee at the time of hiring beginning October 1, 2013.
